Report from Senate GD16-10

Board of Governors meeting of October 6, 2016

Senate met on September 21, 2016. This report contains items which are presented to the Board of Governors for its consideration and information.

I. FOR ACTION BY THE BOARD OF GOVERNORS

1. 474th Report of the Academic Policy Committee

[D16-02]

Senate reviewed the Academic Policy Committee's proposal for the creation of the McGill Centre for Islam and Science and recommended that it be approved by the Board.

The Centre represents a major initiative to deal with the role of rational scientific and philosophical discourse in Islamic societies, both past and present. A great deal of commentary, both scholarly and otherwise, has been put forth in the past decade regarding the role of Islam (both as a religion and as a civilization) in either promoting or hindering scientific development. Among the goals of the Centre is to deal with these and related issues through a tripartite structure consisting of interrelated research, teaching, and outreach components. The Centre will focus on science policy in Islamic countries, historical perspectives on the rational sciences in Islam and scientific literacy in Muslim societies.

Be it resolved that the Board of Governors, on the recommendation of Senate, approve the creation of the McGill Centre for Islam and Science/Centre McGill de l'Islam et de la science.

In accordance with the Committee's terms of reference, Senate received this annual report for information. The document provided an overview of the matters that the Committee addressed during the 2015-2016 academic year and its plans for 2016-2017. The Deputy-Provost (Student Life and Learning) highlighted that the Committee focused on the Innovation Fund and priorities for the current academic year include continuing to develop and define administrative processes related to the Innovation Fund and proposing minor changes to the Committees Terms of Reference.
